- ✓ 95% of our graduates tested at levels equal to or better than their more income-advantaged peers in Orleans Parish
- ✓ 100 preschoolers successfully transitioned from Educare New Orleans to kindergarten

# PARENTS AS EDUCATORS

- Home-based visits and group socialization activities that promote secure parent-child relationships and help parents provide high quality learning experiences to their infants and toddlers in language, literacy, social, and emotional functioning and physical skills
- A research based curriculum (*Partners for a Healthy Baby*) that delivers developmentally, linguistically, and culturally appropriate activities that support young children's cognitive, social, and emotional growth for later success in school
- Resources to promote overall well-being for the family unit, including physical (vision, speech, and hearing screenings) and mental health services
- A strategic system of care to support all enrolled pregnant women's ongoing needs
- Type III licensed through the State of Louisiana, as a home-based option for parents of young children

# COMMUNITY & SUPPORTIVE SERVICES

- Direct support to individuals and families residing at Columbia Parc at the Bayou District and Heritage Senior Residences
- Essential services to help vulnerable residents achieve self-sufficiency and personal growth, while ensuring overall well-being for our local community
- Management of Harmony House, a supervised visitation program that protects at-risk families suffering from domestic violence

## Thanks To You...

- ✓ 300 at-risk families, individuals, and seniors received vital services, including employment (job search and job skills development), family planning, counseling services (relationship and conflict resolution), youth development, utility assistance, housing/rental support, and food and nutrition assistance
- ✓ 80 single female-headed families received emergency financial assistance and ongoing support, preventing homelessness and future crises
- ✓ 153 families received free VITA (Volunteer Income Tax Assistance) services from IRS certified volunteers, ensuring efficient and timely tax return preparation with electronic filing
- ✓ Harmony House successfully provided safe and secure visits for 143 vulnerable families





# ADULT SERVICES

## Kingsley House provides:

- Year-round day care for vulnerable senior citizens, veterans, and medically fragile adults
- Support to caregivers while they are at work by offering safe, secure, stimulating and productive environments for loved ones
- Exciting social and recreational activities, including weekly bingo games, arts and crafts, music therapy, community and cultural activities, and other celebrations
- A community-based alternative to unnecessary nursing home placement and hospitalization by ensuring health and well-being

- ✓ 95% of participants maintained or improved health and avoided transitioning into nursing home care or hospitalization
- ✓ 100% of caregivers were able to maintain their jobs or obtain new employment while receiving respite through Adult Services



# COMMUNITY COUNSELING CENTER

Louis participated in a business startup special training course that was made available to our Educare parents and the training was a game changer for his small business. His experiences in Dr. Erica Murray's entrepreneur's seminar were life altering.

Prior to this specialized training, Cager grew his business based on word of mouth and now he credits the course with instilling in him a sense of confidence and purpose to actively promote his business.

Touted as a trusted global business consultant, Murray's book *CEO to the Power of YOU* has served as his business bible and primer for future expansion plans. Murray, a New Orleans local herself, grew up in the St. Bernard Housing Development (now Columbia Parc and home to our Educare School and Community and Supportive Services program), and believes in sharing her business expertise with locals to help them succeed in becoming more economically stable and break the cycle of poverty.

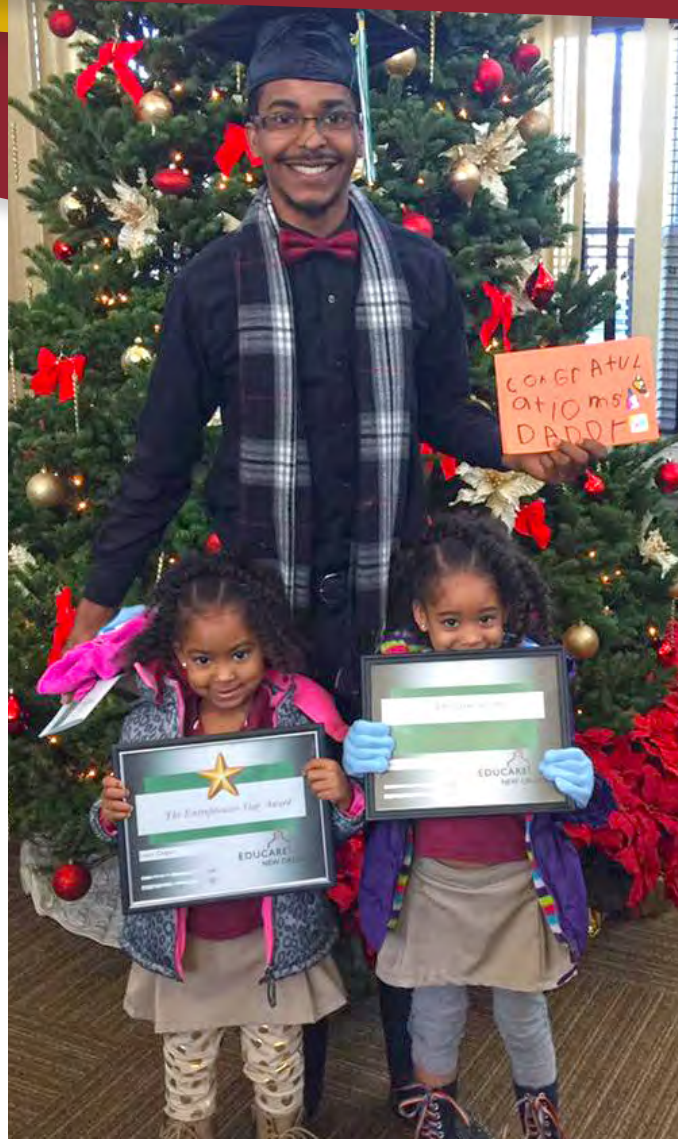


Building off of the business startup training, Cager recently won a major contract with InterContinental Hotels Group (IHG), a global hotel brand, to provide them with corporate meetings and event support. ***Within the first year after having participated in training, Cager's profits increased by \$36,000.***

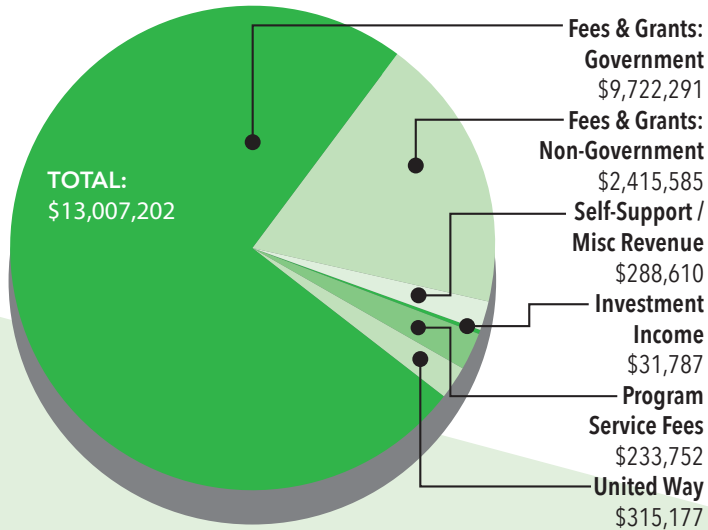

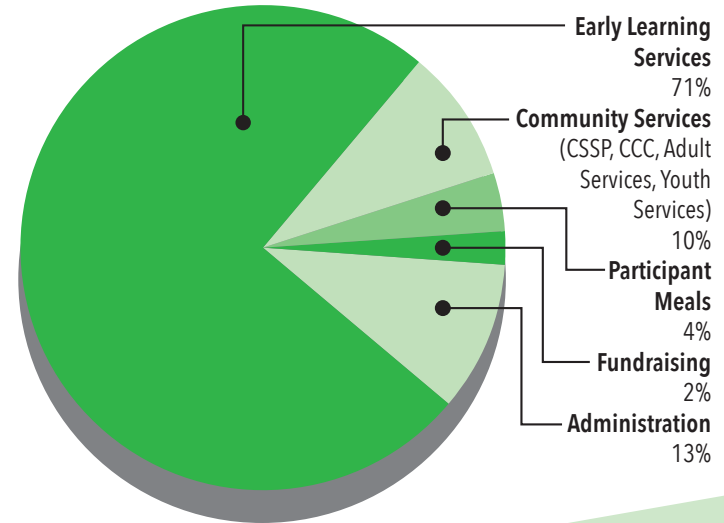
# 2015-16 FISCAL YEAR IN NUMBERS

Reflects Net Amount after Capital Outlay funding of \$4,759,031 for Fees & Grants: Government

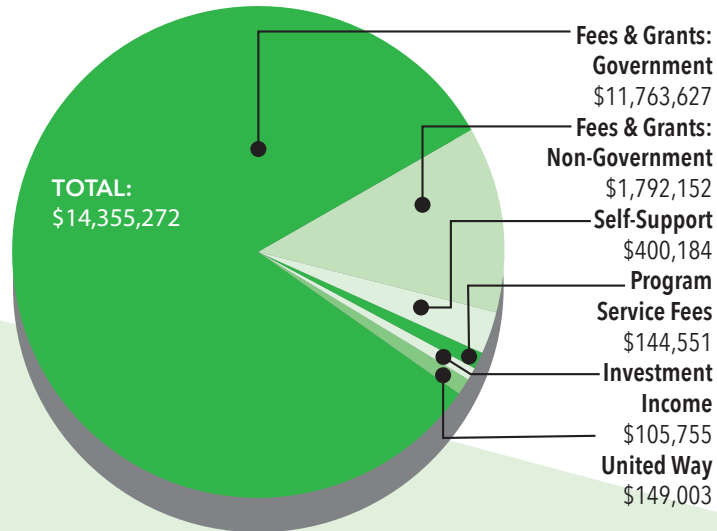
## EXPENSES Fiscal Year 2015-2016



# 2016-2017 FISCAL YEAR IN NUMBERS

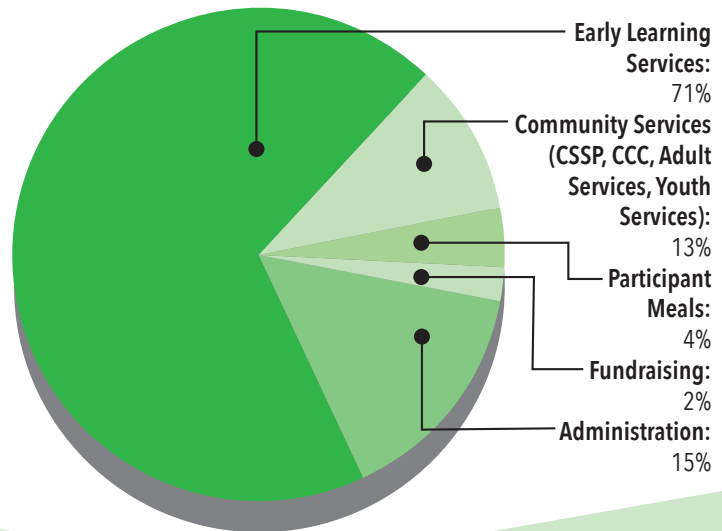
## SOURCE OF INCOME
